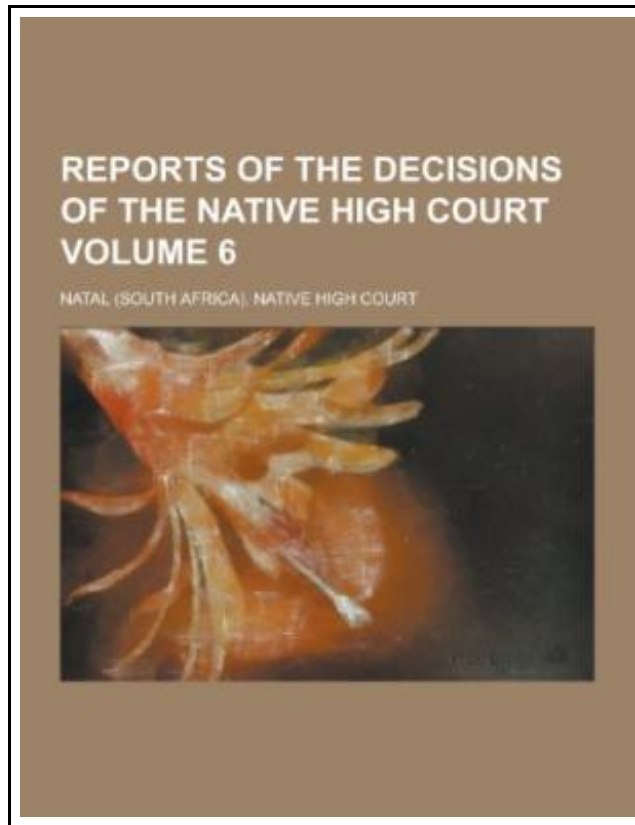

Held, that expert evidence is only allowable to describe a tribal custom or local usage, but not with resptct to general native law. (Before Campbell, J.P., Boshoff, J., and Chadwick, J.) This matter first came before the Court in March last, and proceeded to trial, lasting five days. The Court was, however, unable to come to a definite decision, owing to the contradictory nature of the evidence. Almost every material point by the plaintiff was met by counter-statement or flat denial by the defendant and his witnesses. The result was that the defendant was absolved...
