GAO reviewed the Navys processes for determining annual enrollment requirements for functional and skill training courses. GAO found that: (1) the Navy uses two processes to plan enrollment requirements, one for certain types of skills courses and one for all other courses; (2) the process for forecasting enrollments for skills courses is not well documented and divides responsibilities among too many different organizations; and (3) there is no standard process for forecasting enrollments in other types of courses and individual training activities prepare their own forecasts. GAO also found that: (1) in fiscal year 1984, planned attendance exceeded actual attendance in almost 50 percent of the courses offered; (2) actual attendance exceeded planned enrollment in only 20 percent of the courses offered; (3) in 19 percent of the courses, utilization remained at less than 80 percent for more than 3 years; and (4) in several instances, better planning and monitoring could have reduced the number of necessary instructor positions.
